Said Council hereby finds that that certain map surveyed by
THOMAS S. W. WONG, Registered Civil Engineer, and entitled
"RESUBDIVISION OF TORREY PINES HEIGHTS SUBDIVISION UNIT NO. 1
Being a subdivision of Lot 1 of Torrey Pines Heights Subdivision
Unit No. 1, in the City of San Diego, County of San Diego, State
of California, according to Map thereof No. 7217, filed in the
office of the County Recorder on February 25, 1972.", is made
in the manner and form prescribed by law and conforms to the
surrounding surveys.

BE IT FURTHER RESOLVED, that said Council hereby rejects
as a dedication for public street Parcel "A" marked "Reserved
for Future Street" as shown on this map, under the provisions
of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map; and said
Council has rejected Parcel "A" marked "Reserved for Future
Street" shown on this map within this subdivision, all as
above stated.

the Clerk of the Board of Supervisors of the County of San Diego,
California.
