BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be and he is hereby authorized and directed to conform those guidelines entitled "PROCESS FOR ENVIRONMENTAL IMPACT REVIEW--PUBLIC AND PRIVATE PROJECTS (INTERIM)," adopted by Resolution No. 206816, on file in the office of the City Clerk as Document No. 741808, to the provisions of Ordinance No. 10952 (New Series) and any amendments thereto, and of the California Environmental Quality Act of 1970, as amended.

2. Further, that the City Manager be and he is hereby authorized and directed to make all future changes and modifications to said City guidelines required by and consistent with the amendment of said Ordinance, the amendment of said Quality Act of 1970, and those guidelines, criteria, objectives and standards promulgated by the State Office of the Secretary of Resources Agency. No other modifications or changes shall be permitted without approval by Council resolution.

3. That Resolution No. 206816, adopted October 31, 1972, be and the same is hereby amended to reflect the above provisions, changes and adoption of this resolution.
