

RESOLUTION NO. 207071 DEC 14 1972

WHEREAS, at its regular meeting on February 4, 1972, the Historical Site Board officially designated the Santa Fe Depot as an historical site; and

WHEREAS, said structure was subsequently designated in the National Registry as a National Historical Landmark; and

WHEREAS, on June 12, 1972, the Atchison, Topeka and Santa Fe Railroad Company filed an application for a demolition permit for said structure; and

WHEREAS, in accordance with Section 26.02 of the San Diego Municipal Code, on July 7, 1972, the Historical Site Board requested the maximum delay in approval of said such demolition and on said date a 180-day hold was placed on the demolition permit; and

WHEREAS, the Historical Site Board has given considerable study to the determination of ways and means to preserve said structure; and

WHEREAS, said Section 26.02 of the San Diego Municipal Code provides that, "If at the end of the first one hundred (100) days of the aforesaid one hundred eighty (180) day period it is found that the preservation of the site, building or structure cannot be fully accomplished within the one hundred eighty (180) day period and the Historical Site Board determines that such preservation can be satisfactorily

completed within an additional period not to exceed one hundred eighty (180) days, the Historical Site Board may recommend to the City Council that a request for extension be granted."; and

WHEREAS, on October 6, 1972, the Historical Site Board by resolution determined that the Santa Fe Depot can be preserved if there is an extension of 180 days to the period of withholding of the demolition permit; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That an extension of time not to exceed 180 days be granted pursuant to Municipal Code Section 26.02 on the withholding of a demolition permit for the Santa Fe Depot.
