BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Carlon Meter Sales Co. 2. Hersey Products, Inc. 3. Gamon-Calmet Industries, Inc. 4. Badger Meter, Inc. 5. Rockwell Manufacturing Co. 6. Muesco, Inc. 7. Neptune Meter Co. 8. Hersey Products, Inc., Ametrol Division are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of COLD WATER METERS AND PARTS as may be required for a period of one year beginning January 1, 1973 through December 31, 1973, per prices on file in the Purchasing Department, as follows:

1. Carlon Meter Sales Co. for Schedule I, Items 1,2,3,4,5 and 6 and for Carlon Meter Parts at a 20% trade discount from list prices; terms net 30 days plus sales tax, less trade-in.
2. Hersey Products, Inc. for Schedule II, Item 1; Schedule IV, Items 1,2, 3 and 4; Schedule V, Items 1,2,3,4 and 5; and Schedule VI, Item 2, and for Hersey Meter Parts at a 25% trade discount from list prices; terms net 30 days plus sales tax; with an option to renew the contract for an additional one-year period, January 1, 1974 through December 31, 1974 at the same terms, prices and conditions.
3. Gamon-Calmet Industries, Inc. for Schedule II, Items 2 and 3, and Schedule VI, item 3, and for Gamon-Calmet Meter Parts at a 15% discount from list prices; terms net 30 days plus sales tax; with an option to renew the contract for an additional one-year period, January 1, 1974 through December 31, 1974 at the same terms, prices and conditions.
4. Badger Meter, Inc. for Schedule II, Item 4, and for Badger Meter Parts at an 18% trade discount from list prices for Badger Domestic Meters and at an 8% trade discount from list prices for Badger Commercial Meters; terms net 30 days plus sales tax; with an option to renew the contract for an additional one-year period, January 1, 1974 through December 31, 1974 at the same terms, prices and conditions.
5. Rockwell Manufacturing Co. for Schedule VI, Items 1,4,5 and 6 and for Rockwell Meter Parts at a 30% trade discount from list prices; terms net 30 days plus sales tax; with an option to renew the contract for an additional one-year period, January 1, 1974 through December 31, 1974 at the same terms, prices and conditions.
6. Muesco, Inc. for parts for various water meters at a trade discount of 5% from list prices; terms net 30 days plus sales tax; with an option to renew the contract for an additional one-year period, January 1, 1974 through December 31, 1974 at the same terms, prices and conditions.
7. Neptune Meter Co. for parts for Neptune Meters at a trade discount of 16½% from list prices; terms net 30 days plus sales tax.
8. Hersey Products, Inc., Ametrol Division, for parts for American Meters at a trade discount of 10% from list prices; terms 1% 10 days plus sales tax; with an option to renew the contract for an additional one-year period, January 1, 1974 through December 31, 1974 at the same terms, prices and conditions.
