BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Offer to Dedicate of MIDWAY-FRONTIER DEVELOPMENT CO., a Joint Venture, executed in favor of The City of San Diego, bearing date of October 17, 1972, granting to said City an offer to dedicate to public use for future street purposes a portion of Pueblo Lot 276 of the Pueblo Lands of San Diego, as more particularly described in said Offer to Dedicate, be and the same is hereby accepted on the conditions therein expressed.

BE IT FURTHER RESOLVED, that by this acceptance the City does not dedicate to public use for street purposes the land described in said instrument, but reserves the right to so dedicate at a future time.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to file the foregoing said offer to dedicate in the office of the Recorder of San Diego County.
