

RESOLUTION NO. 207094 DEC 19 1972

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO ACCEPTING THE GENEROUS CONTRIBUTION
OF MR. AND MRS. R. LEE VAN DE WETERING FOR USE
IN CONNECTION WITH SAN DIEGO PARK DISTRICT NO. 3
(MISSION HILLS CANYON)

WHEREAS, this Council has ordered the formation and
establishment of San Diego Park District No. 3 (Mission Hills
Open Space District) by Resolution No. 207091,
adopted on December 19, 1972, pursuant to proceedings taken
under the San Diego Park District Procedural Ordinance of 1969
(Division 8); and

WHEREAS, Mr. and Mrs. R. Lee Van de Wetering of 4034 St. James
Place, San Diego, California, have generously offered to contribute
to The City of San Diego the sum of one thousand dollars (\$1,000)
for the purpose of assisting in the acquisition and improvement
of the San Diego Park District No. 3 (Mission Hills Open Space
District); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as
follows:

1. That the City Manager of The City of San Diego be and
he is hereby authorized to accept the generous contribution of
one thousand dollars (\$1,000) from Mr. and Mrs. R. Lee Van de
Wetering, and he is further directed to deposit said contribution
into the special improvement fund created for San Diego Park
District No. 3 (Mission Hills Open Space District) in accordance
with a letter from Mr. and Mrs. Van de Wetering dated December 15,

1972, and filed with the City Clerk as Document No. 742268.
Furthermore, that said contribution shall be used only in
connection with said Park District No. 3, and that a reduction
in the assessments ordered by this Council pursuant to Resolution
No. 207091 shall be made as a result of said contribution.
It is understood that in the event a subsequent surplus should
occur in the special improvement fund established for said Park
District No. 3, no refund shall be made to Mr. and Mrs. Van de
Wetering.

2. That this Council does hereby commend Mr. and Mrs. R. Lee
Van de Wetering for this act of civic generosity and does hereby
publicly express on behalf of the citizens of this City a debt
of gratitude to Mr. and Mrs. Van de Wetering.
