BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$35,000 is hereby authorized from the Capital Outlay Fund (245) solely and exclusively for the purpose of providing funds for engineering services and construction of concrete cross gutters throughout the City as required and supplementing Resolution No. 177773 in this amount.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work for the engineering services and construction of the concrete cross gutters designated above, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.
