WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
John Martinez	WATER UTILITIES	\$385	This suggester received a \$100 award a year ago for designing and making a device to inject chlorine into stand-pipes and reservoirs much more easily. It has been found to have been used much more than estimated, and the additional savings warrant an award of \$385 more.
William V. Hidalgo	WATER UTILITIES	\$120	This Equipment Repairman invented a magnetic device for testing water meters and registers to determine the location of leaks. This device saves considerable time for testing and also prevents unnecessary overhauling of water meters.
Gail Jeromin	PROPERTY	\$25	Five letters being frequently written as originals are now handled as form letters for a saving of the time of both Property Agents and Clerks.
Elizabeth Langworthy	PUBLIC WORKS	\$20	It was proposed that a blanket Purchase Order be established for typewriter maintenance for typewriters not covered by contract for maintenance. This saves issuing 15 additional Purchase Orders a year at a cost of \$ 210.
Charles Guthrie L. E. Curtis Randell Swanson	Police	\$20	These officers collaborated on a comprehensive proposal for the improvement of the Family Crisis program. This has been partially adopted, and may be more extensively. The Suggestion Awards Committee recommends a \$20 award for a significant proposal that has considerable potential value.
