

RESOLUTION NO. 207125 DEC 26 1972

WHEREAS, the acquisition of the Santa Fe Depot will both preserve a major historical structure and provide facilities for a much-needed central city transportation center; and

WHEREAS, the Depot, built in the early 1900s, is located in the Centre City of San Diego, between Broadway and "B" Streets at Kettner Boulevard, and is centrally located in relation to other transportation activities and sets on the City's only fixed rail corridor; and


WHEREAS, the restoration of the Depot and conversion to a central transit terminal fits harmoniously within Centre City Redevelopment plans and can provide important linkages relative to the central business district, growing activities of the Unified Port District, the Embarcadero area and the Harbor Island/San Diego International Airport activity center; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized to submit for and on behalf of said City, an application to the Department of Transportation for a federal grant

under the Urban Mass Transportation Act of 1964, for the purpose of acquiring and refurbishing the Santa Fe Depot property and structure for use as a central transportation center.
