ORDINANCE NO. 10968 JAN 2 1973 (New Series)

AN ORDINANCE INCORPORATING ALL R-2 ZONED PROPERTY LOCATED WITHIN AN AREA IN SOUTH MISSION BEACH, BOUNDED BY CAPISTRANO PLACE ON THE NORTH, THE PACIFIC OCEAN ON THE WEST, MISSION BAY PARK ON THE EAST, AND THE MISSION BAY CHANNEL ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2B ZONE, AS DEFINED BY SECTION 101.0410.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 243 (NEW SERIES), ADOPTED JUNE 5, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all R-2 zoned property located within an area in South Mission Beach, bounded by Capistrano Place on the North, the Pacific Ocean on the West, Mission Bay Park on the East, and the Mission Bay Channel on the South, in the City of San Diego, California, within the boundary of the district designated "R-2B" on Zone Map Drawing No. B-2684, filed in the office of the City Clerk under Document No. 741937 be, and it is hereby incorporated into R-2B Zone, as such zone is described and defined by Section 101.0410.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 243 (New Series), adopted June 5, 1933, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.



Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
