That a portion of Pueblo Lot 1788, Lots 1 through 3, Lane Square; Lot 1, Marshall Court; and portions of Lots 21 and 22, Homeland Villas Unit 2, in the City of San Diego, California, within the boundary of the district designated "C-15" on Zone Map Drawing No. B-2662.1, filed in the office of the City Clerk under Document No. 741603 be, and they are hereby incorporated into C-1S Zone, as such zone is described and defined by Section 101.0430 of the San Diego Municipal Code.
