AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 7, SECTIONS 67.55, 67.56 AND 67.57 OF THE SAN DIEGO MUNICIPAL CODE RELATING TO CHANGING WATER RATES FOR DOMESTIC, COMMERCIAL, INDUSTRIAL AND AGRICULTURAL USE.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter VI, Article 7 of the San Diego Municipal Code be and the same is hereby amended by amending Section 67.55 to read as follows:

SEC. 67.55 WATER RATES - DOMESTIC, COMMERCIAL AND INDUSTRIAL SERVICE WITHIN THE CITY OF SAN DIEGO

The rates to be charged and collected for water supplied in any one month for Domestic, Commercial and Industrial service within the City, and for all purposes for which no other rate for water supplied for use within the City is in this Article provided, shall be as set forth in this Section, to wit:

a. Customer Charge, per meter:

The rates to be charged and collected for water supplied in any one month for Domestic, Commercial and Industrial service outside the City, and for all purposes for which no other rate for water supplied for use outside the City is in this Article provided, shall be as set forth in this Section, to wit:

The amount computed at the rates set forth under Section 67.55 of the ordinance, multiplied by 2.00.

Nothing contained in this section shall be construed to change or modify any existing legal contracts or obligations between The City of San Diego and any person, firm or corporation as to the rate or rates for water or the obligations in connection therewith.

The following monthly rates shall be charged and collected for water supplied through a single meter for Combined Irrigation and Domestic service within the City:

	15,001 - 20,000 square feet	4.25
	20,001 square feet and over	4.25 plus \$1.25 for each 5,000 square feet or fraction thereof in excess of 20,000 square feet.
