AN ORDINANCE AMENDING ORDINANCE NO. 10873 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1972-73 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 739786, AS ADOPTED AND AMENDED THEREIN, RELATING TO THE POSITION AND SALARY SCHEDULE FOR FUND 100, DEPARTMENT 09.00.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Ordinance No. 10873 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1972-73 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended to amend that portion of the Position and Salary Schedule for Department 09.00, Fund 100, to reflect and authorize the addition of the following personnel:

Senior Stenographer	1

Section 2. That the City Auditor and Comptroller be and he is hereby fully authorized and directed to transfer the sum of \$34,140 from the Unallocated Reserve (53.30) to Department 09.00, Object Account 1151, to be used solely and exclusively for the purpose of providing funds for personal services for the remainder of fiscal year 1973.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
