AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 4  
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING  
SECTION 84.09 RELATING TO RESTRICTIONS ON THE  
USE OF BICYCLES ON SIDEWALKS AND OTHER PUBLIC  
RIGHTS OF WAY.

BE IT ORDAINED, by the Council of The City of San  
Diego, as follows:

Section 1. That Chapter VIII, Article 4 of the San  
Diego Municipal Code be and it is hereby amended to read  
as follows:

SEC. 84.09 BICYCLE RIDING RESTRICTED

a. No person shall operate a bicycle  
upon any sidewalk fronting any commercial business  
establishment unless official signs are posted  
authorizing such use.

b. Any person riding or operating a  
bicycle on any public right of way shall exercise  
due care and yield the right of way to pedestrians.

Section 2. This ordinance shall take effect and be  
in force on the thirtieth day from and after its passage.

1. No person shall operate a bi-

2. Any person riding or operating  
a bicycle on any public right of  
way shall exercise due care and  
yield the right of way to pedes-  
trians.

Section 7. This ordinance shall take  
effect and be in force on the thirtieth  
day next after its passage.
