AN ORDINANCE INCORPORATING LOTS 2 THROUGH 20, BLOCK 13, GRANTVILLE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1S AND M-1B ZONES, AS DEFINED BY SECTIONS 101.0430 AND 101.0435.2, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7226 (NEW SERIES), ADOPTED DECEMBER 27, 1956, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 2 through 20, Block 13, Grantville, in the City of San Diego, California, within the boundaries of the districts designated "C-1S" and "M-1B" on Zone Map Drawing No. B-2682.1, filed in the office of the City Clerk under Document No. 742276 be, and they are hereby incorporated into C-1S and M-1B Zones, as such zones are described and defined by Sections 101.0430 and 101.0435.2, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 7226 (New Series), adopted December 27, 1956, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
