ORDINANCE NO. 10993 FEB 13 1973 (New Series)

AN ORDINANCE INCORPORATING A PORTION OF LOT 4, FRIARS ROAD SUBDIVISION, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10578 (NEW SERIES), ADOPTED MAY 13, 1971, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot 4, Friars Road Subdivision, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-2694.1, filed in the office of the City Clerk under Document No. 742301 be, and it is hereby incorporated into CO Zone, as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10578 (New Series), adopted May 13, 1971, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
