ORDINANCE NO. (New Series)

AN ORDINANCE INCORPORATING ALL R-4 ZONED PROPERTY BOUNDED BY MARKET STREET ON THE NORTH, 28TH STREET ON THE EAST, IMPERIAL AVENUE ON THE SOUTH, AND 25TH STREET ON THE WEST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12942, APPROVED SEPTEMBER 4, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all R-4 Zoned property bounded by Market Street on the north, 28th Street on the east, Imperial Avenue on the south, and 25th Street on the west, in the City of San Diego, California, within the boundary of the district designated "R-2" on Zone Map Drawing No. B-2703.3, filed in the office of the City Clerk under Document No. 742671 be, and it is hereby incorporated into R-2 Zone, as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12942, approved September 4, 1930, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
