AN ORDINANCE AMENDING CHAPTER X, ARTICLE 2, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE, BY AMENDING SECTION 102.0206, RELATING TO SUSPENSION OF REQUIREMENTS - VARIANCE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 2, Division 2 of the San Diego Municipal Code be amended by amending Section 102.0206 to read as follows:

SEC. 102,0206 SUSPENSION OF REQUIREMENTS - VARIANCE

In approving a tentative map, the Subdivision Review Board, Commission or Council may grant a suspension of any of the subdivision requirements set forth or referred to in this Code, except underground facilities and the requirement for street dedication contained in Section 102.0209, paragraph 5, which may be waived only by the City Council, provided such suspensions are not inconsistent with State law. A variance from the lot area, frontage, width, depth and front yard or setback requirements of the various zones described in Chapter X, Article 1 of this Code may be granted by the Commission or the Council. Any such suspension or variance shall be based on a sufficient showing that there are special circumstances or conditions affecting the property in question and that such suspension or variance,
