

ORDINANCE NO. 11015 MAR 8 1973
(New Series)

AN ORDINANCE INCORPORATING PORTIONS OF LOTS 1 AND 2, BAYVIEW DRIVE-IN THEATRE TRACT NO. 2, AND PORTIONS OF LOTS 8-15, NESTOR ACRES, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8029 (NEW SERIES), ADOPTED DECEMBER 18, 1958, AND ORDINANCE NO. 10862 (NEW SERIES), ADOPTED JUNE 29, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Lots 1 and 2, Bayview Drive-In Theatre Tract No. 2, and portions of Lots 8-15, Nestor Acres, in the City of San Diego, California, within the boundary of the district shown as Area 9 and designated "R-2" on Zone Map Drawing No. 379.4, filed in the office of the City Clerk as Document No. 742884 be, and they are hereby incorporated into R-2 Zone, as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8029 (New Series), adopted December 18, 1958, and Ordinance No. 10862 (New Series), adopted June 29, 1972, of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
