AN ORDINANCE INCORPORATING LOTS 11-21 AND PORTION OF LOT 22, PALM VIEW TRACT; LOTS 1-10, MOORS SUBDIVISION; PORTION OF SECTION 21; AND PORTION OF SECTION 28, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101,0409 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 8029 (NEW SERIES), ADOPTED DECEMBER 18, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

Section 2. That Ordinance No. 8029 (New Series), adopted December 18, 1958, of the Ordinances of The City of San Diego insofar as the same conflicts herewith.

This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
