ORDINANCE NO. 11019 MAR 8 1973 (New Series)

AN ORDINANCE INCORPORATING LOT 1, CORONADO TERRACES UNIT NO. 2, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10100 (NEW SERIES), ADOPTED JULY 13, 1969, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 1, Coronado Terraces Unit No. 2, in the City of San Diego, California, within the boundary of the district shown as Area 14 and designated "R-2" on Zone Map Drawing No. 379. 4, filed in the office of the City Clerk as Document No. 742884 be, and it is hereby incorporated into R-2 Zone, as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10100 (New Series), adopted July 13, 1969, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
