ORDINANCE NO. 11021 MAR 8 1973 (New Series)

AN ORDINANCE INCORPORATING LOT 3, MONTGOMERY PALISADES NEIGHBORHOOD SHOPPING CENTER, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8292 (NEW SERIES), ADOPTED APRIL 28, 1960, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 3, Montgomery Palisades Neighborhood

Section 2. That Ordinance No. 8292 (New Series), adopted April 28, 1960, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
