

ORDINANCE NO. 11022 MAR 8 1973  
(New Series)

AN ORDINANCE INCORPORATING LOT 1, RANCHO CASTER, AND LOTS 258 AND 259, PACIFICA HILLS UNIT NO. 8, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 AND R-2A ZONES, AS DEFINED BY SECTIONS 101.0409 AND 101.0410, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10061 (NEW SERIES), ADOPTED JUNE 5, 1969, AND ORDINANCE NO. 10248 (NEW SERIES), ADOPTED FEBRUARY 26, 1970, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 1, Rancho Caster, designated "R-2," and Lots 258 and 259, Pacifica Hills Unit No. 8, designated "R-2A," all in the City of San Diego, California, within the boundary of the district shown as Area 20 on Zone Map Drawing No. 379.4, filed in the office of the City Clerk as Document No. 742884 be, and they are hereby incorporated into R-2 and R-2A Zones, as such zones are described and defined by Sections 101.0409 and 101.0410, respectively, of the San Diego Municipal Code.


Section 2. That Ordinance No. 10061 (New Series), adopted June 5, 1969, and Ordinance No. 10248 (New Series), adopted February 26, 1970, of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith.
