AN ORDINANCE INCORPORATING LOTS 1 AND 2, PRINCESS DEL SOL UNIT NO. 4, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9755 (NEW SERIES), ADOPTED JANUARY 18, 1968, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 1 and 2, Princess Del Sol Unit No. 4, in the City of San Diego, California, within the boundary of the district shown as Area 22 and designated "R-2" on Zone Map Drawing , filed in the office of the City Clerk as Document No. 742884 be, and they are hereby incorporated into R-2 Zone, as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 9755 (New Series), adopted January 18, 1968, of the ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

This ordinance shall take effect and be in force Section 3. on the thirtieth day from and after its passage.
