ORDINANCE NO. 11033 APR 5 1973

AN ORDINANCE INCORPORATING LOTS 4 AND 5, CORONADO HIGHLANDS UNIT NO. 1., IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10490 (NEW SERIES), ADOPTED JANUARY 21, 1971, AND ORDINANCE NO. 10486 (NEW SERIES), ADOPTED JANUARY 21, 1971, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 4 and 5, Coronado Highlands Unit No. 1, in the City of San Diego, California, within the boundary of the district shown as Area 8 and designated "R-2" on Zone Map Drawing No. <u>C-379.5</u>, filed in the office of the City Clerk as Document No. <u>743074</u> be, and it is hereby incorporated into R-2 Zone, as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10490 (New Series), adopted January 21, 1971, and Ordinance No. 10486 (New Series), adopted January 21, 1971, of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
