AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 15, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTIONS 33.1501.6 AND 33.1501.7 RELATING TO FEMALE EMPLOYEES IN CABARETS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 3, Division 15, of the San Diego Municipal Code be, and it is hereby amended by repealing the following sections:

SEC. 33.1501.6 FEMALE EMPLOYEES--ACTS PROHIBITED WITHOUT PERMIT;

SEC. 33.1501.7 FEMALE EMPLOYEES--PERMITS REQUIRED.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

Section 221501, Chapter III, Article 3, of the San Diego Municipal Code is hereby amended to read as follows:

SECTION 221501. FEMALE EMPLOYEES IN CABARETS. ACTS PROHIBITED.

SECTION 2215017. FEMALE EMPLOYEES IN CABARETS. PERMITS.

This ordinance shall take effect on the thirtieth day after its passage.
