SEC. 23.0301 GENERAL REQUIREMENTS
[Rule II, Section 1 of the Rules of the Civil Service Commission]

Unless waived, all applicants must

- (1) be citizens of the United States or persons lawfully admitted to the United States for permanent residence pursuant to Section 1101(a)(20) of the Immigration and Nationality Act of 1952, as amended; provided, however, that all applicants for peace officer classifications shall be citizens of the United States as required by state law;
- (2) be actual residents of the County of San Diego for at least one year immediately preceding the date of filing application; provided, however, that this requirement

may be waived by the Commission in order to secure the necessary number of qualified applicants;

- (3) meet the minimum requirements stated in the examination announcement;
- (4) be able to speak, read, and write English.

  Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
