

ORDINANCE NO. 11047

(New Series)

AN ORDINANCE AMENDING CHAPTER V, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTIONS 56.01, 56.01.1 AND 56.02, RELATING TO DISORDERLY CONDUCT, PLACES AND PUBLICATIONS. BE IT ORDAINED by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 6, of the San Diego Municipal Code be, and it is hereby amended by repealing the following sections:

SEC. 56.01. OBSCENE, INDECENT, IMMORAL BOOKS, PHOTOGRAPHS, WRITINGS, FIGURES, ETC.—PROHIBITED.

SEC. 56.01.1. SAME—SEIZURE AND DESTRUCTION.

SEC. 56.02. PROSTITUTION, FORNICATION, OTHER LEWD OR INDECENT ACTS, ETC.—PROHIBITED.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
