AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1,  
DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE,  
BY AMENDING SECTION 101.0101.20 RELATING TO  
THE DEFINITION OF FAMILY.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter X, Article 1, Division 1 of the  
San Diego Municipal Code be amended by amending Section 101.0101.20  
to read as follows:

SEC. 101.0101.20 FAMILY

Two or more persons related by blood or marriage,  
as well as any other person who is legally adopted, or  
has been placed by a court of competent jurisdiction,  
or is under legal guardianship, living together in a  
dwelling unit, and shall include licensed foster family  
homes in which care is provided for not more than six  
children, including children of the foster family.

Section 2. This ordinance shall take effect and be in force  
on the thirtieth day from and after its passage.
