AN ORDINANCE AMENDING CHAPTER VII,  
ARTICLE 2 OF THE SAN DIEGO MUNICI-  
PAL CODE BY AMENDING SECTION 72.06  
RELATING TO TAXICAB DRIVERS' LICENSES.

BE IT ORDAINED, by the Council of The City of San  
Diego as follows:

Section 1. That Chapter VII, Article 2 of the  
San Diego Municipal Code be, and the same is hereby amended  
by amending Section 72.06 to read as follows:

SEC. 72.06 TAXICAB DRIVERS: LICENSES

No person shall drive or operate any of  
the vehicles mentioned in Section 71.01.5 unless  
such person has a taxicab driver's identification  
card issued by the Sheriff of the County of  
San Diego.

Section 2. This ordinance shall take effect and  
be in force on July 1, 1973.


