AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 5  
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING  
SECTION 95.0118 RELATING TO EXISTING SIGNS.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter IX, Article 5 of the San Diego  
Municipal Code be amended by amending Section 95.0118 to read  
as follows:

SEC. 95.0118 EXISTING SIGNS

A Use Permit for every sign in existence on  
April 5, 1973 shall be obtained within 270 days from  
that date. Signs in existence on the above date which  
do not conform to the provisions of this Code, but  
which were constructed, erected, affixed or maintained  
in compliance with all previous regulations, shall be  
regarded as nonconforming signs which may be continued  
from the above date for a period not to exceed two  
years before conformance or removal. Any sign owner,  
whether a sign user or a sign lessor or lessee, may  
seek relief from this provision by appealing to the Sign  
Code Board of Appeals in accordance with the provisions  
set forth in Section 95.0122 through Section 95.0125  
for a longer use period.

A. Use Permit for every sign in existence on April 6, 1973 shall be obtained within 270 days from that date. Signs in existence on the above date which do not conform to the provisions of this Code but which were constructed, erected, affixed or maintained in compliance with all previous regulations shall be regarded as nonconforming signs which may be continued from the above date for a period not to exceed two years before conformance or removal. Any sign owner, whether a sign user or a sign lessor or lessee, may seek relief from this provision by appealing to the Sign Code Board of Appeals in accordance with the provisions set forth in Section 95.0122 through Section 95.0125 for a longer use period.

Section 2 This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
