AN ORDINANCE AMENDING CHAPTER II, ARTICLE 7,
DIVISION 29, OF THE SAN DIEGO MUNICIPAL CODE
BY AMENDING SECTION 27.2937 RELATING TO
CAMPAIGN STATEMENT--PUBLIC INSPECTION AND
COPYMAKING.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter II, Article 7, Division 29, of
the San Diego Municipal Code be amended by amending Section
27.2937 to read as follows:

SEC. 27.2937 CAMPAIGN STATEMENT--PUBLIC INSPECTION
AND COPYMAKING


Campaign statements are to be open for public

hours at the office of the City Clerk and during open
hours on the Saturday preceding an election at the
Central Library, San Diego Public Library, 820 E Street.
Copies of statements or parts of statements shall be
provided by the City Clerk at a price of not more than
ten cents (\$0.10) per page copied.


