AN ORDINANCE AMENDING ORDINANCE NO. 10873 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1972-73 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Section 2 of Ordinance No. 10873 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1972-73 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" is hereby amended by adding the following directions to the end of item 7, TRANSIENT OCCUPANCY TAX FUND, to read as follows:

7. TRANSIENT OCCUPANCY TAX FUND

Any monies deposited to the Transient Occupancy Tax Fund in excess of the amounts committed by this annual budget are hereby appropriated for the purpose for which the fund was created.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


