AN ORDINANCE AMENDING CHAPTER III, ARTICLE 1,  
DIVISION 3, OF THE SAN DIEGO MUNICIPAL CODE BY  
ADDING SECTION 31.0390 RELATING TO LICENSE FEE -  
COLLECTION, TRANSPORTATION AND DISPOSAL OF REFUSE.

BE IT ORDAINED, by the Council of The City of San Diego, as  
follows:

Section 1. That Chapter III, Article 1, Division 3, of the  
San Diego Municipal Code be amended by adding Section 31.0390 to  
read as follows:

SEC. 31.0390 LICENSE FEE - COLLECTION, TRANSPORTATION  
AND DISPOSAL OF REFUSE

Every person who operates a service route or routes  
for the collection, transportation and disposal of refuse  
from residential, commercial, institutional or industrial  
premises in the City of San Diego shall pay a license fee  
as set forth in and pursuant to Section 66.0112 of this  
Code, and the provisions of Section 31.0303 of this Code  
shall not apply to such persons.

Section 2. This ordinance shall take effect and be in force  
on the thirtieth day from and after its passage.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
