AN ORDINANCE AMENDING CHAPTER III,
ARTICLE 1 OF THE SAN DIEGO MUNICIPAL
CODE BY AMENDING SECTION 31.0344
RELATING TO TAXICABS.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter III, Article 1 of the San
Diego Municipal Code be, and the same is hereby amended by
amending Section 31.0344 to read as follows:

SEC. 31.0344 LICENSE TAX--OPERATING TAXICAB

Every person conducting, managing or carrying
on the business of running or operating any taxicab
shall pay a license tax of Two Hundred Dollars
(\$200.00) per car per year, payable annually.

Section 2. For purposes of administrative application
this ordinance shall take effect and be in force on July 1,
1973.

Section 3. In compliance with Sections 17 and 23 of
the Charter of The City of San Diego this ordinance shall
take effect and be in force on the thirtieth day from and
after its passage.
