

ORDINANCE NO. 11093 JUL 12 1973
(New Series)

AN ORDINANCE INCORPORATING LOTS A AND B, BLOCK 226, HORTON'S ADDITION, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12987, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots A and B, Block 226, Horton's Addition, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-2698, filed in the office of the City Clerk under Document No. 743638 be, and they are hereby incorporated into CO Zone, as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12987, approved October 20, 1930 of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
