AN ORDINANCE SETTING ASIDE AND DEDICATING LOT 3, ALLIED GARDENS COMMUNITY PARK, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK, AND NAMING SAID PARK "ALLIED GARDENS COMMUNITY PARK."

WHEREAS, The City of San Diego is the owner of Lot 3, Allied Gardens Community Park in the City of San Diego; and

WHEREAS, it is the desire of the people of the City of San Diego to set aside and dedicate forever Lot 3 of Allied Gardens Community Park, for public use and enjoyment as and for a public park to be used by all the public for park and recreational purposes; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the hereinafter described real property be, and the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named "Allied Gardens Community Park."

Section 3. That the real property so dedicated and named is described as follows:

Lot 3 of Allied Gardens Community Park  
according to the Map thereof No. 4975  
filed in the Office of the County Recorder  
of San Diego County, May 22, 1962.


