

ORDINANCE NO. 11113 SEP 6 1973
(New Series)

AN ORDINANCE INCORPORATING ALL THAT LAND GENERALLY BOUNDED BY INTERSTATE 805 AND HIGHWAY 163 AND CLAIREMONT MESA BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-20 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 10546 (NEW SERIES), ADOPTED APRIL 15, 1971, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That all that land generally bounded by Interstate 805 and Highway 163 and Clairemont Mesa Boulevard, in the City of San Diego, California, within the boundary of the district designated "R-1-20" on Zone Map Drawing No. C-385.1, filed in the office of the City Clerk under Document No. 744285 be, and it is hereby incorporated into the R-1-20 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10546 (New Series), adopted April 15, 1971 of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
