

ORDINANCE NO. 11115 SEP 6 1973
(New Series)

AN ORDINANCE INCORPORATING A PORTION OF LOT 44, HORTON'S PURCHASE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE R-2 AND THE CA ZONES, AS DEFINED BY SECTIONS 101.0409 AND 101.0428.1, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8455 (NEW SERIES), ADOPTED MARCH 16, 1961, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot 44, Horton's Purchase, in the City of San Diego, California, within the boundaries of the districts designated "R-2" and "CA" on Zone Map Drawing No. B-2710, filed in the office of the City Clerk as Document No. 744290 be, and it is hereby incorporated into the R-2 and the CA Zones, as such zones are described and defined by Sections 101.0409 and 101.0428.1, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 8455 (New Series), adopted March 16, 1961, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
