

ORDINANCE NO. 11118 SEP 6 1973
(New Series)

AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 2,
DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE BY
ADDING SECTION 62.0404.5 RELATING TO CLEARING
AND GRUBBING INCIDENTAL TO LAND DEVELOPMENT WORK.

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That Chapter VI, Article 2, Division 4, of the San
Diego Municipal Code be amended by adding Section 62.0404.5 to read
as follows:

SEC. 62.0404.5 CLEARING AND GRUBBING INCIDENTAL
TO LAND DEVELOPMENT WORK

Clearing and grubbing of vegetation which must be done in
connection with land development is an integral part of the
total work covered by the land development permit or subdivision
agreement. Any person desiring to do land development work
shall not undertake clearing and grubbing operations until the
appropriate permit or agreement has been obtained. For the
purposes of this section, "clearing and grubbing" shall mean the
removal of any and all types of vegetation; the removal of roots,
etc., from land; and the clearing or breaking up of the surface
of land by digging. This section shall not apply to any work
being performed pursuant to a City of San Diego mandated Weed
and Litter Abatement Program.

Section 2. This ordinance shall take effect and be in force on
the thirtieth day from and after its passage.

ORDINANCE AMENDING CHAPTER VI, ARTICLE 2, DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE, BY ADDING SECTION 22.0404.5 RELATING TO CLEARING AND GRUBBING INCIDENTAL TO LAND DEVELOPMENT WORK.

IT IS ORDERED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 2, Division 4, of the San Diego Municipal Code be amended by adding Section 22.0404.5 to read as follows:
SEC. 22.0404.5. CLEARING AND GRUBBING INCIDENTAL TO LAND DEVELOPMENT WORK.

Clearing and grubbing of vegetation which must be done in connection with land development is an integral part of the total work covered by the land development permit or subdivision agreement. Any clearing and grubbing to be done in connection with such work shall not constitute clearing and grubbing operations until the appropriate permit or agreement has been obtained. For the purpose of this section, clearing and grubbing shall mean the removal of any and all types of vegetation; the removal of roots, etc., from land; and the clearing or breaking up of the surface of land by digging. This section shall not apply to any work being performed pursuant to a City of San Diego mandated Weed and Litter Abatement Program.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
