

ORDINANCE NO. 11131 SEP 27 1973
(New Series)

AN ORDINANCE INCORPORATING CERTAIN LAND CURRENTLY ZONED R-1-6, IN THE ENCANTO AREA, GENERALLY BOUNDED BY FEDERAL BOULEVARD ON THE NORTH, CITY LIMITS ON THE NORTH AND EAST, BROADWAY ON THE SOUTH, AND 60TH STREET ON THE WEST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-10 ZONE AS DESCRIBED BY SECTION 101.0407, AND REPEALING ORDINANCE NO. 10452 (NEW SERIES), ADOPTED DECEMBER 1, 1970, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all that land currently zoned R-1-6, in the City of San Diego, California, within the boundary of the district shown as Area F-1 and designated "R-1-10" on Zone Map Drawing No. B-2705.2, filed in the office of the City Clerk as Document No. 744924 be, and it is hereby incorporated into R-1-10 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10452 (New Series), adopted December 1, 1970, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
