

ORDINANCE NO. 11136 OCT 4 1973
(New Series)

AN ORDINANCE INCORPORATING LOT 217, HARBORVIEW HEIGHTS UNIT 7, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CN ZONE, AS DEFINED BY SECTION 101.0426 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9201 (NEW SERIES), ADOPTED APRIL 22, 1965, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 217, Harborview Heights Unit 7, in the City of San Diego, California, within the boundary of the district designated "CN" on Zone Map Drawing No. B-2552, filed in the office of the City Clerk under Document No. 744686 be, and it is hereby incorporated into CN Zone, as such zone is described and defined by Section 101.0426 of the San Diego Municipal Code.

Section 2. That Ordinance No. 9201 (New Series), adopted April 22, 1965, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
