AN ORDINANCE OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING, CALLING, PROVIDING FOR AND GIVING NOTICE OF A GENERAL MUNICIPAL ELECTION TO BE HELD IN THE CITY OF SAN DIEGO, IN THE SAN DIEGO UNIFIED SCHOOL DISTRICT, AND IN THE SAN DIEGO COMMUNITY COLLEGE DISTRICT TO BE HELD TUESDAY, NOVEMBER 6, 1973, AND CONSOLIDATING THE GENERAL MUNICIPAL ELECTION WITH THE STATEWIDE SPECIAL ELECTION TO BE HELD ON THE SAME DATE.

WHEREAS, at a meeting held on August 21, 1973, the City Council of The City of San Diego adopted Resolution No. 208656, requesting the Board of Supervisors of the County of San Diego to order the consolidation of the general municipal election to be held on November 6, 1973, with the state-wide special election to be held on the same date; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. It is hereby ordered that a General Municipal Election will be held in the City of San Diego, in the San Diego Unified School District, and in the San Diego Community College District on Tuesday, the 6th day of November, 1973, for the purpose of electing the following officers:

COUNCILMAN, District No. 7	Four-Year Term
MEMBER, BOARD OF EDUCATION, District B	Four-Year Term
MEMBER, BOARD OF EDUCATION, District C	Four-Year Term
MEMBER, BOARD OF EDUCATION, District D	Two-Year Term
MEMBER, COMMUNITY COLLEGE GOVERNING BOARD OF TRUSTEES, District A	Four-Year Term

Section 2. The polls for said elections shall be open at 7:00 a.m. (local time) on November 6, 1973, and shall remain open continuously until 8:00 p.m. (local time) on the same day at which time the polls shall be closed, except as provided in Section 14436 of the Elections Code of the State of California.

Section 3. The general municipal election called for November 6, 1973, in the City of San Diego is hereby ordered consolidated with the Statewide Special Election to be held on the same date. Within the City of San Diego, the San Diego Unified School District, and the San Diego Community College District the precincts, polling places and officers of the election for the general municipal election shall be the same as those provided for in the Statewide Special Election, all as set forth in the List of Election Officers and Polling Places for the Statewide Special Election proposed to be published in the San Diego Union.

Section 4. The Board of Supervisors of the County of San Diego is hereby authorized to canvass the returns of the general municipal election and these elections shall be held in all respects as if there were only one election, and within the City only one form of ballot shall be used. The Board of Supervisors shall certify the results of the canvass of the returns of this general municipal election to the Council of The City of San Diego which shall then declare the results of the election.

Section 5. Except as otherwise provided in this ordinance, the general municipal election shall be conducted as provided by law for other municipal elections of the City.

Section 6. The City Clerk is hereby directed to cause this ordinance to be published once in the official newspaper of The City of San Diego.

Section 7. This ordinance shall take effect immediately.
