## ORDINANCE NO. 11146 OCT 2 5 1973 (New Series)

AN ORDINANCE AMENDING ORDINANCE NO. 10963 (NEW SERIES) TO PROVIDE THAT BUILDING PERMITS ISSUED DURING THE PERIOD AUGUST 1, 1972 THROUGH OCTOBER 27, 1973 NOT EXPIRE UNTIL NINETY (90) DAYS FROM THE DATE OF ISSUANCE OF A DEVELOPMENT PERMIT OR CERTIFICATE OF EXEMPTION FROM THE SAN DIEGO COAST REGIONAL COMMISSION OR, IF APPEALED, FROM THE CALIFORNIA COASTAL ZONE CONSERVATION COMMISSION OR A FINAL ADJUDICATION OF A COURT OF COMPETENT JURISDICTION; PROVIDED, HOWEVER, THAT COMMENCEMENT OF WORK WAS DELAYED PURSUANT TO COMPLIANCE WITH SECTIONS 27104 AND 27400 OF THE CALIFORNIA PUBLIC RESOURCES CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 10963 (New Series), adopted December 26, 1972, be and the same is hereby amended to read as follows:

"Section 1. That building permits issued during the period August 1, 1972 through October 27, 1973 not expire for failure to commence work until ninety (90) days from the date of issuance of a Development Permit or Certificate of Exemption from the California Coastal Zone Conservation Commission or a final adjudication of a court of competent jurisdiction; provided, however, that commencement of work was delayed pursuant to compliance with Sections 27104 and 27400 of the California Public Resources Code."
