

ORDINANCE NO. 11152  
(New Series)

NOV 1- 1973

AN ORDINANCE INCORPORATING ALL THAT PROPERTY BOUNDED BY GRAPE STREET AND I-5 ON THE NORTH, I-5 ON THE EAST, "E" AND "L" STREETS ON THE SOUTH, AND PACIFIC HIGHWAY ON THE WEST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CBD ZONE, AS DEFINED BY SECTION 101.0433 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING CERTAIN ORDINANCES OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all that property bounded by Grape Street and I-5 on the north, I-5 on the east, "E" and "L" Streets on the south, and Pacific Highway on the west, in the City of San Diego, California, within the boundary of the district designated "CBD" on Zone Map Drawing No. C-381, filed in the office of the City Clerk under Document No. 744945 be, and they are hereby incorporated into CBD Zone, as such zone is described and defined by Section 101.0433 of the San Diego Municipal Code.

Section 2. That the following ordinances of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith:
