

RESOLUTION NO. 207169 JAN 9 1973

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, a portion of Tierrasanta Boulevard in Lots 27, 37 and 38, Rosedale Tract, has been relocated through the approval and dedication on this date of a new alignment for Tierrasanta Boulevard, as more particularly shown on Drawing No. 14858-D on file in the office of the City Clerk as Document No. 742332; and

WHEREAS, those properties adjoining that portion of Tierrasanta Boulevard to be vacated will continue to have access or will be accessible by the alternate route dedicated on this date; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Tierrasanta Boulevard in Lots 27, 37 and 38, Rosedale Tract, as more particularly shown on Drawing No. 12652-B on file in the office of the City Clerk as Document No. 742333, which said drawing is attached hereto and made a part hereof, be and the same is hereby vacated.

2. That with respect to the aforementioned, the City does hereby relinquish all rights to and interest in the slope rights adjacent to said vacated streets.

3. That the City Clerk shall cause a certified copy of this resolution with drawing, attested by him under seal, to be recorded in the office of the County Recorder.




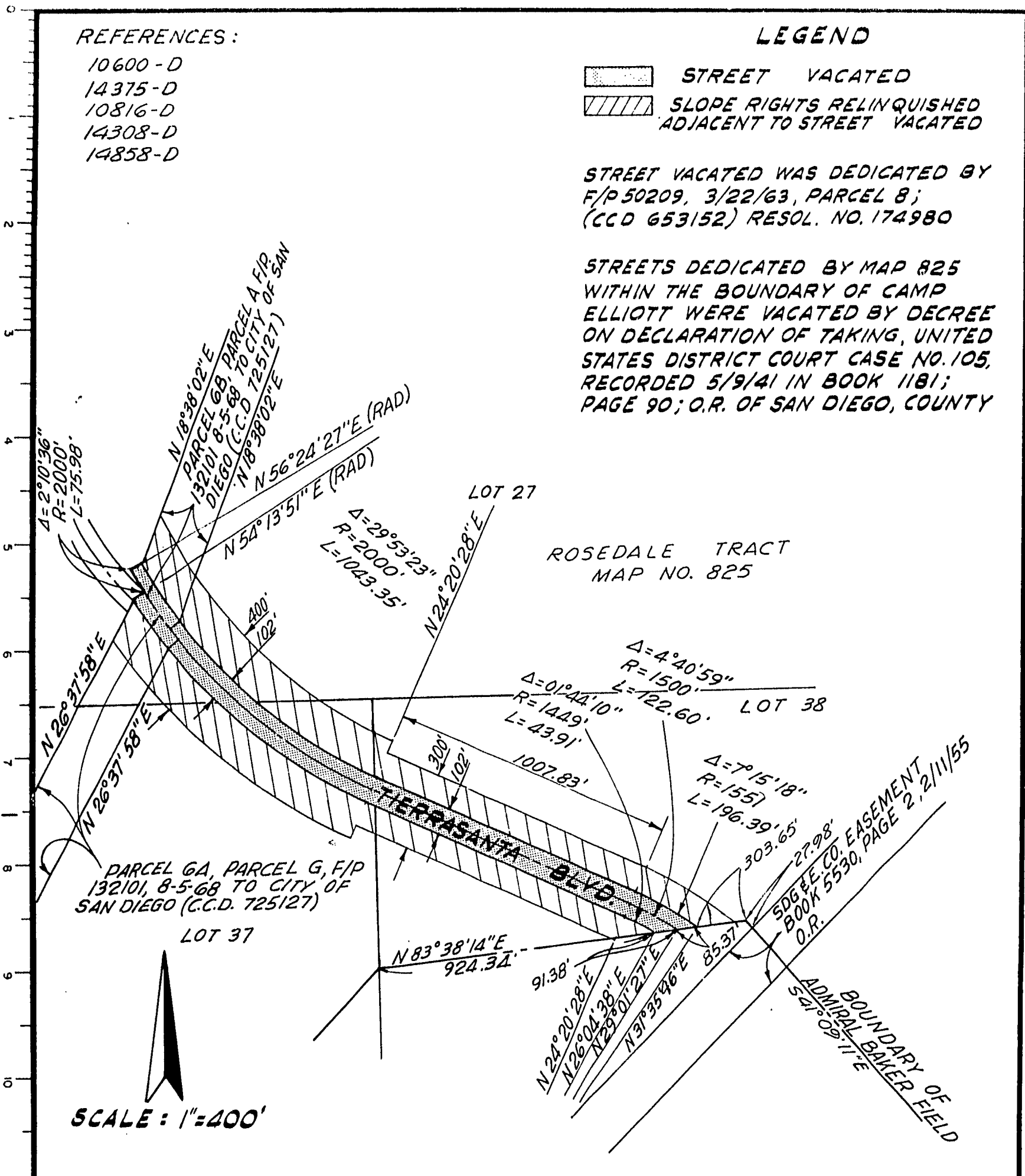
