

RESOLUTION NO. 207198 JAN 16 1973

WHEREAS, The City of San Diego is the owner of portions of the Southwest Quarter of Quarter Section Lot 103, Rancho de la Nacion, according to Map thereof No. 166, on file in the office of the San Diego County Recorder; and

WHEREAS, the owners of the adjoining land have requested that the City quitclaim to them all of the City's interest in said property; and

WHEREAS, said property was acquired for the purpose of a cathodic easement and has been determined surplus by the Water Utilities Director of said City; and

WHEREAS, the City desires to negotiate the sale of said real property interest to the owners of said property under the provisions of Section 22.0902(e) of the San Diego Municipal Code which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, this project is exempt from an Environmental Assessment because it is a public activity involving a real property interest with a fair market value of less than \$20,000; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished only by negotiation; and

WHEREAS, it has been determined by the Property Department staff that the value of the property is the sum of fifty-five dollars (\$55.00); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property interest described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 742412, be and the same is hereby authorized to be sold by negotiation for the sum of fifty-five dollars (\$55.00) to the Owners in Fee Simple of Record.

2. That the Mayor and the City Clerk of The City of San Diego be and they are hereby authorized and empowered to execute for and on behalf of said City a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 742412, quitclaiming to the OWNERS IN FEE SIMPLE OF RECORD, portions of the Southwest Quarter of Quarter Section Lot 103, Rancho de la Nacion, as more particularly described in said form of quitclaim deed.

3. That no broker's commission shall be paid by City on the herein described sale.

4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director of The City of San Diego for further handling.
