

RESOLUTION NO. 207210 JAN 16 1973

APPROVING MAP OF MCKINNON SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled "MCKINNON SUBDIVISION Being a subdivision of Lot 17 of the Southern Title Guaranty Company's Subdivision of Pueblo Lot 1801, according to Map thereof No. 1864, filed in the office of the County Recorder of San Diego County, October 20, 1925, together with a portion of Pueblo Lot 1801 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe, in 1870, a copy of which was filed in the office of the County Recorder of San Diego County, November 1, 1921, and is known as Miscellaneous Map No. 36, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

Said Council further finds that reasonable public access is available to land below the ordinary high-water mark within or at a reasonable distance from the subdivision; namely, from the termination of Dawes Street to the west and Everts Street to the east of the subdivision.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
