

RESOLUTION NO. 207224 JAN 1st 1973

APPROVING MAP OF DIXON'S SUBDIVISION NO. 4

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by SAMUEL F. SAFINO, Registered Civil Engineer, and entitled "DIXON'S SUBDIVISION NO. 4 Being a subdivision of a portion of Lot 5 of Lloyd's subdivision of Pueblo Lot 197 in The City of San Diego, County of San Diego, State of California, according to Map thereof No. 844, filed in the office of County Recorder April 11, 1898.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Dixon Place and Santa Cruz Avenue, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Dixon Place adjacent and contiguous to Lots 3 and 4 all as shown and granted on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said

public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
