1. That the bid of \$3,289.00 by Wilcox Electric, Inc. dba Arrow Electric, a corporation, for the CONSTRUCTION OF STREET LIGHTING SYSTEMS ON SUNSET CLIFFS BOULEVARD BETWEEN DEL MAR AVENUE AND BERMUDA AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742061.
2.
